Dear Colleague,

We are pleased to invite you to attend Argent Communications Group's 2019 annual California Water Law & Policy Conference.

California's water law and policy remain moving targets of ever-changing issues, and this year several topics have garnered our attention. Following years of low rainfall, this year California's snowpack is high, and reservoir water abundant. This brings up concerns about water rights and water-rights reporting; and how near- and far-term plans are addressing future water supply, drought and flood control issues.

The federal Clean Water Act and its jurisdictional reach has become quite uncertain, despite efforts by the U.S. Army Corps of Engineers to define the issue. And while the federal government tries to reign in the reach of the CWA, the State Water Resources Control Board is simultaneously moving to expand its reach into water quality regulation.

We're also covering other timely issues of growing concern: the critical implications of changes to managing the Colorado River; ongoing SGMA compliance issues for groundwater sustainability plans (GSPs) and the unique challenges involved with critically over-drafted water basins; San Francisco Bay/Sacramento-San Joaquin Delta water quality, habitat restoration, and the ever-changing WaterFix Project; whether or not to tax water in an effort to insure a clean water supply statewide; movement regarding the scope of the Public Trust Doctrine; and the unique challenges of a newly legal cannabis industry in the state facing water supply and quality issues.

Our conference is designed to hone in on the issues that will most impact your water-related practice and the governance of water in the state. As an attendee, you will gain practical knowledge on the legal, policy, and technical sides of the issues from our outstanding faculty from federal and state regulatory agencies, the academic community, water supply agencies, engineering consultants, and top water attorneys from throughout the state. Over the two days, you will also have invaluable networking opportunities with the faculty and your colleagues.
